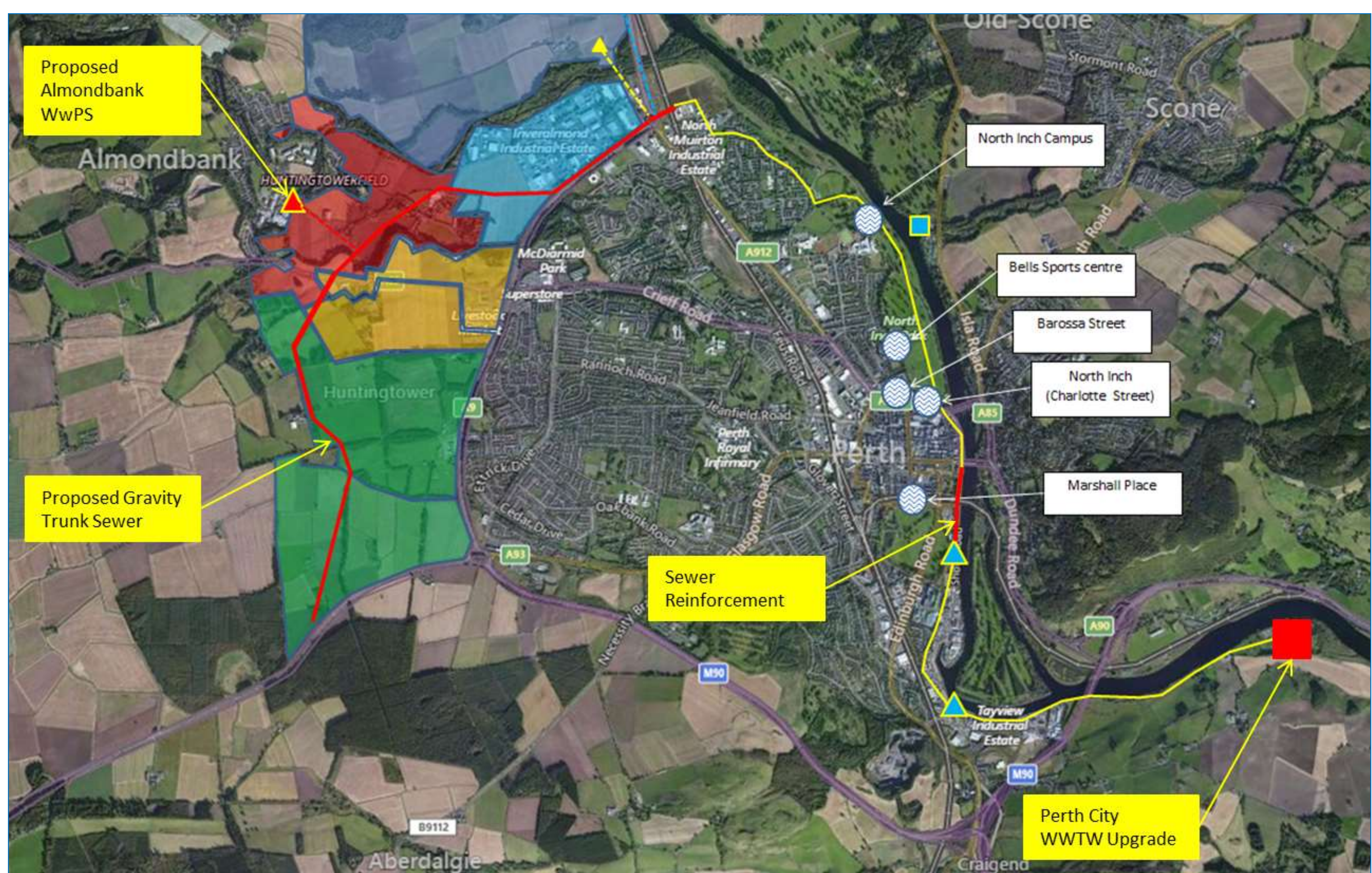
Making Perth Climate Ready

We know that Perth is growing and that our climate is changing.

Scottish Water has been developing significant investment plans to respond to the continuing growth of the city to the north and west.

Extensive survey and modelling work carried out in partnership with Perth & Kinross Council before the pandemic gave us a more accurate and detailed understanding of all the city's underground and above ground drainage systems than ever before.

This identified an opportunity to both provide the capacity needed for new homes and businesses to connect to the sewer system, while also improving the network's resilience to intense rainstorms.



Overview of investment plans for Perth's sewer network and Waste Water Treatment Works. The central sewer upgrade in Tay Street and Shore Road provides capacity for new development areas and Almondbank to be connected, while reducing the known risk of sewer flooding in the five areas indicated between Muirton and Marshall Place.

Tay Street and Shore Road

The central element of our investment in Perth's sewer network is a section of 'super sewer' in Tay Street and Shore Road.

Around 500 metres of new trunk sewer will be installed next to the River Tay with a pipe diameter of 2.2 metres. This will significantly add to the capacity of the existing trunk sewer:

- providing additional capacity for new homes and businesses to connect as part of the city's continuing growth;
- helping the city become climate-ready by reducing the risk of sewer flooding during intense rainfall when the city's drainage systems can be overwhelmed by high volumes of stormwater.

Construction work of this scale in a busy city centre location is very challenging. As well as the installation of the new sewer itself, significant other infrastructure needs to be diverted to make this possible.

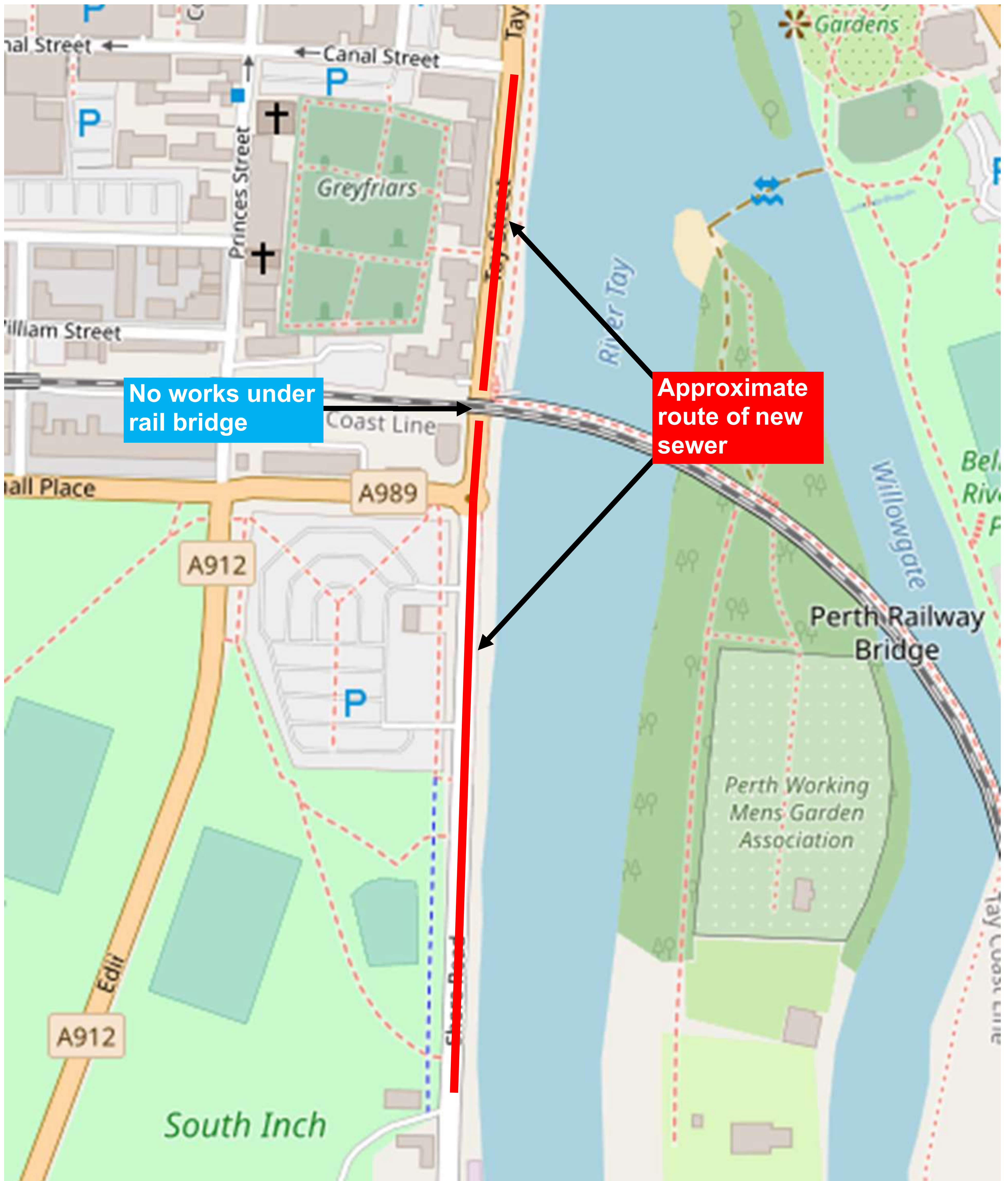
The work can only be delivered safely and efficiently with Tay Street and Shore Road being closed to normal traffic. We understand this is disruptive and will do all we can to ensure the temporary traffic and access arrangements work smoothly.

Tay Street traffic plan

Tay Street will be closed from the junction with Canal Street to the roundabout at Marshall Place/Shore Road from Monday 15th May 2023, for up to 20 months.

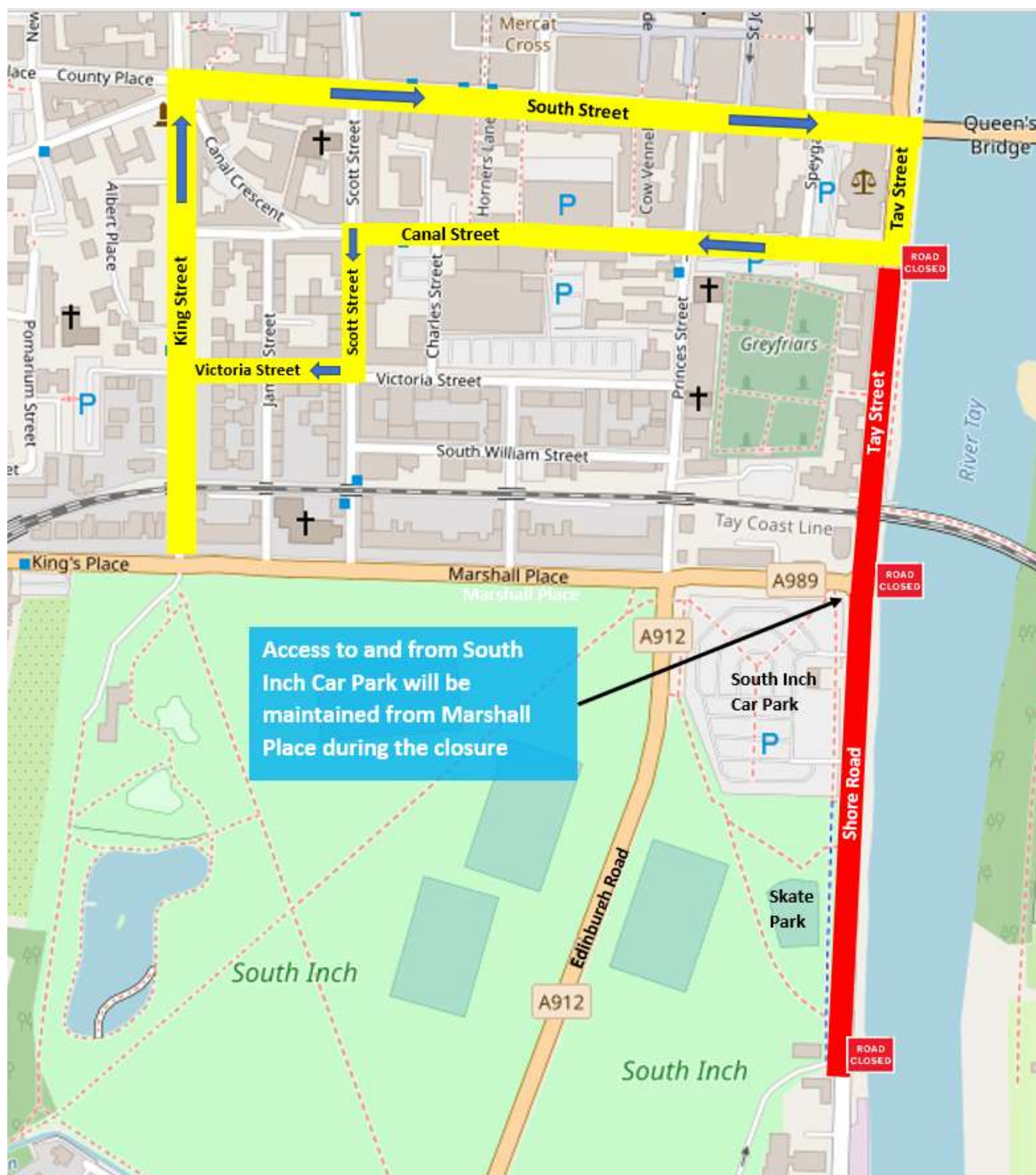
- The initial part of this work will be major gas utility diversion works, carried out by Scottish Gas Networks (SGN), which must be safely completed prior to the installation of a large 2.2 metre diameter sewer and associated chambers.
- Diversions will be in place throughout via Canal Street, South Street, Scott Street, Victoria Street and King Street. Please follow all signage in place.
- Local access for residents and business deliveries will be maintained as far as possible - although there will be periods when the arrangements will need to change. Our site team will liaise directly with local residents and businesses about this.
- Pedestrian and cycle access will be maintained, including access to Moncrieffe Island via the footbridge alongside the railway.
- Please note there will be no parking on Tay Street within the area of the road closure.
